REVIEW AGENDA OF THE SESSION I - FINANCE

1. APPROVAL OF ADMINISTRATIVE 2011

the Mayor withdrew from the Assembly to not take part in debate or vote. The Municipal Council, meeting under the chairmanship of Mr. Philippe Mercier, Vice Chairman of the Finance Committee, without the presence of the Mayor, after being present the results of the management of the municipality for the year 2011, approved In 2011 the administration of the main budget is as follows:

The City Council gave its approval to the Mayor for his management in 2011, and said that the remains found to achieve at the end of fiscal 2011 will be included in the main budget 2012, in expenditures: 679,800, € 00 and Investment Income: 358.979,00 €

2..APPROVAL OF THE MANAGEMENT

2011Municipal Council, after being presented the original 2011 budget and amending decisions related to it, the final titles of receivables, details of expenditure and the number of warrants issued, the slips titles revenue slips mandates, management accounts prepared by the Receiver accompanied states developing third-party accounts and the statement of assets, liabilities the state, the state remains in recover and the state remains to achieve,

The City Council recalls that the recipient has taken in his writings the amount of each balance sheet position of 2010, that all securities issued and the revenue of all mandates payment sequenced and has carried out all the operations order that was prescribed to pass through his writings,

1) Acting on all transactions from 1 January 2011 to 31 December 2011 including those relating to

the additional day, 2) Deciding on budget execution for 2011 regarding different budget sections 3) Deciding on Accounting inactive values, the City Council said the account Management prepared for 2011, stamped and certified by the budget officer, calls or observations or reservations on his part.

3. ALLOCATION OF INCOME ACCOUNT 2011 ADMINISTRATIVE BUDGET MAIN

The City Council after hearing the presentation by Philippe Mercier, Vice Chairman of the Finance Committee, after voting in 2011 and arrested the Administrative Account compiled by Danielle JOCALLAZ, Mayor and after have found to comply with the Account Management 2011 prepared by Mr. Receiver Municipal, whereas the outcome of the Joint Management 2011 showed a surplus of € 643.617.77 cumulative operation and the results of the 2011 administration of the common revealed an investment of surplus accumulated € 51.519.13, unanimously, shall allocate the sum of € 533.617.77 in 1068 has "capitalized operating surplus" in the 2012 budget the main budget. The City Council also decided to resume budget 2012 investment to the tune of € 51.519.13 Account "001" and the recovery in 2012 budget operating surplus to the tune of € 110,000 to the "account surplus 002".

4. LOCAL DIRECT TAXATION: VOTE THE RATE OF DIRECT TAXES FOR LOCAL 2012 the Mayor said that the 2012 budget maintains an ambitious investment policy and continued improvement of public services to the residents of the town of Ferriereorder.

However, in do not increase the tax burden of households shared in a difficult economic context and given the evolution of direct local tax base reported by the State, it is proposed to the City Council to extend the rates for 2012 voted in 2011. The City Council on the report of the Mayor, unanimously decided to retain the following rates for the year 2012:

- o Rate of Living Tax: 17.39% o Tax rate on developed land: o 26.85% rate of tax on undeveloped land: 181.60% o rate land premium business: 33.02%
- 5. VOTE THE RATE OF TAX FOR REMOVAL OF GARBAGE 2012 the Mayor recalled that by decision of 22 October 2009, the City Council has decided to resume the SIVOM Canton Bozel, effective February 1, 2010 the competence of household waste collection to exercise directly. In addition, the City Council decided, by Resolution No. 065/2010 of 8 July 2010, also take the responsibility of dealing with residual household waste, and Resolution No. 70 of 25 August 2010, the transfer of the SMITOM Tarentaise. Finally, by Resolution No. 79/2010 dated 16 September 2010, the City Council decided to establish and collect from the year 2011 the garbage collection fee. For the record, this tax to finance services for the collection and treatment of residual household waste was collected by the township SIVOM Bozel. The Municipal Council has also decided to resume the zoning applied by SIVOM township Bozel to modulate the amount of tax to the importance of the service rendered assessed according to the

conditions under which the service and its cost as follows:

o RA zone: cadastral sections H, ZN, ZO, ZP, ZK and ZM including the hamlets of La Tania, the Formier and Tagna o P Zone: cadastral sections ZA, ZB, ZC, ZD, ZE, ZH, ZR, ZS notably including the hamlets of Saint-Jean,

La Ferriere, Vignotan, The Chavonnes, Champétel and Villarnard o Zone RB: cadastral sections ZI, ZL including the hamlets of La Nouvaz and Villaflou. This is exposed, the Mayor said that the estimated overall cost of the service for the year 2012 amounted to € 278,258, the principal amounts are as follows:

> Garbage collection: € 145,000, > Treatment: € 62,000 , > Recycling: € 30,349, > Collection of glass: € 3662, > Rental bins: € 4,590; > Using the quay transfer:. € 23,819

In addition, until 2010, the City paid to SIVOM Canton Bozel participation, in addition to the perceived directly by the TEOM SIVOM, intended to balance the service an annual average of around € 30,000. However, the positive trend in the tax base as well as an understanding of various items of expenditure we can no longer bear some of the costs from the general budget and fully fund the service by this tax without using a rate increase this year. Given these elements, the Mayor proposed to the City Council to maintain the tax rate of garbage collection for the year 2012. The City Council on the report of the Mayor, unanimously, sets the tax rate of garbage collection for 2012 as follows: P Area: 15.13%, Zone RA: 11.42%, Zone RB: 10.53%

II-1.TERMS OF COMPENSATION FOR THE STUDENTS OF THE TOWN PERRIERE

the Mayor reminded the council that the 2006 law on equal opportunities and Circular November 2009 on reception conditions for students in local communities, contain certain provisions bonus depending on the duration of training, when the deliberative assembly has previously defined principles.

Under the general operation of the joint, sometimes the town welcomes interns to promote theoretical studies coupled with a practical application of skills. Therefore, it is appropriate that the council deliberates to define the conditions for the payment of such compensation, which are not considered as compensation when they are below certain thresholds. Accordingly, it is proposed to record the following amounts of gratification:

⇒ For Higher-level courses and a term of between one and two months: 300 € per month internship on the

basis of full time. \Rightarrow For Higher-level courses and longer than two months: amount equal to 12.5%

of themaximum social security, or about € 378 to date. It is stated that these amounts will be prorated for students not doing their internship and part-time. City Council decides to establish rewards forth above.
