REVIEW OF THE AGENDA OF THE MEETING

I-FINANCE

AMENDING DECISION N ° 2 - MAIN BUDGET FOR 2012 The City Council on the report of the Mayor, given its Resolution No. 016-2012 of 27 March 2012 approving the 2012 original budget since its Resolution No. 034-2012 of June 13, 2012 Amendment No. 1, 2012, unanimously approved the amending Decision No 2 for 2012 as it has been presented so far in the final stopping:

2. FINANCIAL CONTRIBUTION FOR EXTENSION OF PUBLICDISTRIBUTION NETWORK

ELECTRICITYPC 12 M 1003 the Mayor reminded the council that the provisions of law SRU October 8, 2000 Planning and Housing of 2 July 2003 and on the modernization and development of the public electricity service on 10 February 2000, forced the municipalities as of January 1, 2009 to take over a portion of the construction costs of connection to the electricity network when issuing planning permissions. This contribution is paid to the owner of the work to be performed on electrical networks, namely the company ERDF, through a convention. As part of a project that is the subject of a planning permission in Saint-Jean (PC 73 198 12 M 1003), it is necessary to extend the existing power grid. It is therefore proposed that the City Council authorize the assumption of an amount of \in 2,392.05 HT, corresponding to 40% of the total cost of the work. The City Council, on a report from the Mayor, after deliberation, unanimously approved the extension of the grid necessary for the realization of a building located in St. John's project, said that the necessary credits operation are provided in Budget 2012 Principal of the town.

3. FINANCIAL CONTRIBUTION FOR EXTENSION OF PUBLICDISTRIBUTION NETWORK

ELECTRICITYPC 12 M 1005 the Mayor reminded the council that the provisions of law SRU October 8, 2000 Planning and Housing of 2 July 2003 and on the modernization and

development of the public electricity service on 10 February 2000, forced the municipalities as of January 1, 2009 to take over a portion of the construction costs of connection to the electricity network when issuing planning permissions. This contribution is paid to the owner of the work to be performed on electrical networks, namely the company ERDF, through a convention. As part of a project that is the subject of a planning permission The Tagna (PC 73 198 12 M 1005), it is necessary to extend the existing power grid. It is therefore proposed that the City Council authorize the assumption of an amount of \in 2,814.62 HT, corresponding to 40% of the total cost of the work. The City Council, on a report from the Mayor, after deliberation, unanimously approved the extension of the grid necessary for the realization of a building located in St. John's project, said that the funds necessary for this operation are provided in Budget 2012 Principal of the town.

4. AWARD A GRANT TO PAY OUTSTANDING ASSOCIATION "HOUSE OF TANIA 'DEFICIT FOR THE POOL / CLUB KIDS

2011"Guy Perret withdraws to not take part in the deliberations or vote "the Mayor inform the Municipal Council that, by letter dated 20 December 2011, the association "Tourist Office La Tania" sought the grant by the municipality, a grant of \in 1,942 to finance the deficit recorded in the for the year 2011, under the management of the pool and the club "children." To ensure, in accordance with the provisions of the Convention objectives of 12 February 2009, the operation of the Office of Tourism in all its missions, it is proposed to the City Council to grant the requested grant. The City Council, on a report from the Mayor, unanimously decided to award a grant of \in 1,942 to the "Office de Tourisme de La Tania" Association for the financing of the deficit recorded for the year 2011 in connection with the operation of the pool and the club "children."

5. FIXING RATES OF CATERING FOR SCHOOL YEAR 2012-2013 the Mayor reminded the City Council that local authorities ensure that school meals have the right to determine the selling price of school meals and the evolution of the one based on cost, the mode of production of meals and benefits paid, without being required to comply with price caps set previously on the basis of an annual Prefect. However, the community can not fix a price above the cost per user resulting charges incurred under catering, less subsidies of any kind benefiting the service, including when modulation is applied. For the record, the unit selling price of a meal in the school year 2011/2012 was € 5.00 and corresponded to the purchase price of the meal by the municipality from the company Sodexo, contractor supply meals hot link to the needs of the school restaurant. The meal price charged by the municipality to establish this company, effective September 4, 2012, to 5.20 € Therefore, the Mayor proposes to set at € 5.20 per unit selling price of meals at the canteen school. In addition, the Mayor recalls applicable to determine the tariff to be applied to the monitoring of children with food allergies who eat in the cafeteria, but bring their own meals. The Mayor proposes to fix this price monitoring to 2 € per meal as of 4 September 2012. The City Council, on a report from the Mayor, unanimously fixed to 5.20 € the unit price of meals at school meal service to the school Champétel, fixed to 2.00 € the unit price of sessions custody of children with food allergy who bring their own food, said that these rates will apply until further deliberation on his part.

6. SCHOOL OF MUSIC Moutiers: PAYMENT OF PARTICIPATION 2010 AND 2011 the Mayor said that the town regularly provides financial participation in various organizations where children residing in Ferriere practice a cultural activity. As such, the music school of the Canton of Moutiers, managed by SIVOM Moutiers asked the municipality for the payment of interest in respect of 2010 and 2011. Following the transmission on August 7 the number of children involved, it is possible to determine the amount of municipal participation, established on the basis of € 40 per pupil, the sum of € 120 for 2010/2011 and € 160 for 2011/2012. Accordingly, it is proposed to approve the amount of the financial contribution to be paid SIVOM Moutiers for the operation of the School of Music for two years. The City Council on the report of the Mayor, after deliberation, unanimously decided to grant a financial contribution to the canton of Moutiers SIVOM 120 € for the year 2010/2011 and 160 € for the year 2011/2012.

GENERAL AFFAIRS

II-1.AUTHORIZATION TO SIGN AN AGREEMENT WITH TRI VALLEY SCOP SARL FOR THEIMPLEMENTATION OF TEXTILE CONTAINERS ON THE COMMON

the Mayor informed the City Council that the services of the town came close of Tri Valleys to study the conditions provision of textile containers for residents of the Common Ferriere.

Two locations are likely to accommodate the equipment, namely parking Champétel and the hamlet of Saint John, next municipal workshops.

Finally, it is clear that the introduction of containers, maintenance and rehabilitation will be possible only at the expense of the company for the duration of the agreement, namely one year. This period shall be extended for the same period tacitly, unless terminated by either

party., It is proposed to authorize the Mayor to sign the corresponding agreement. The City Council on the report of the Mayor, unanimously approved the installation of textile collection bins in the territory of the town at locations specified in the explanatory memorandum, and authorizes the Mayor to sign the agreement annexed to the resolution.

2. APPROVAL OF OPENING DATES STATION - WINTER 2012/2013 the Mayor reminded the council members that the service lift and delegate to the SAEM 3 valleys under the Convention on the organization and the operation of the ski area Tania dated 3 November 1989. As the organizing authority of the service, it is common to define the opening of the service to the user, based on proposals made by the grantor dates. It is therefore proposed that the City Council approve the dates of opening and closing the station Tania in the following manner, namely December 15, 2012 to April 26, 2013 for the 2012-2013 winter season. The City Council, having regard to Mrs. Mayor and after deliberation, unanimously decided that the service lift station will be open to the public December 15, 2012 to April 26, 2013 and authorize the Mayor to sign all documents necessary for the implementation of the resolution.

III PLANNING AND WORK

1. REVIEW OF DIA the Mayor informed the members of the Municipal Council declarations of intent to dispose of the property located at about Villaflou, Tania, Vignotan, and Villarnard The Nouvaz. The city council unanimously believes not to exercise the right of first refusal.

2. AUTHORIZED SIGNATURE indentures CONVENTIONS OF SALE

OFPLOTS OF LAND IN THE PROJECT OF THE BIA VIGNOTAN the Mayor reminded the council that the project of making a BIA to Vignotan it is necessary that the municipality can freely dispose of the property tax base. For this, it is necessary to acquire the land corresponding to the influence of the project.

As such, the Mayor has received almost all of the owners of the area and many of them have expressed their agreement to sell their land to the town to enable the realization of this important development for the community and township Bozel project.

Moreover, and that some owners we have not yet made their response to date it will be necessary to seek regular advice on the acquisition projects. Indeed, it appears important for the town to continue these purchases by amicable arrangements to limit to the minimum necessary use any expropriation proceedings.

Against this backdrop, the town is therefore considering to acquire four parcels of cadastred the ZD section under number 101 with an area of 303 m2, number 77 with an area of 511 m2, the number 78 with an area of 697 m2 and in the number 81 with an area of 348 m2.

The acquisition by the municipality will be priced at \in 5 per m2 which will be added any compensation for fruit trees in place up to 80 \in per tree, precision being made here that the acquisition costs are the responsibility of the municipality. It is therefore proposed that the City Council:
