the Mayor reminded the council that the provisions of the laws of the SRU 8 October 2000, Planning and Housing of 2 July 2003 and on the modernization and development of the public electricity service on 10 February 2000, forced the municipalities as of January 2009 to take over a portion of the cost of work Connection to the grid when issuing planning permissions.

### II-1.AUTHORIZATION OF FILING OF APPLICATION FOR LEAVE TO EXECUTION OF WORKS AND FILING OF AN APPLICATION FOR AUTHORIZATION FOR CLEARING THE FOREST TELECABINE

the Mayor informed the council that the SAEM 3 valleys current assignee service lifts of Ferriere, but also Saint Bon, undertook studies to permit replacement of the cable car to the forest, with a 6-seater chairlift.

The good Saint validated the principle of the rise whose arrival station and three towers are located in the municipality of Ferriere, on plots cadastréd H5 and H14.

Accordingly, it is proposed City Council authorize the SAEM 53V to file a record of authorization Running Works (DEAT) on these plots.

Municipal Council on the report of the Mayor, unanimously approved the principle of replacement a portion of the lift of white goat with the installation of a 6-seater chairlift, permits the filing of a Folder Authorization Execution of work on the plots surveyed and registered in 2029, 2030, H14 and H16, states that the arrangements made must take particular care to maintain the quality of the environment by cleaning the site and re-sodding good level

### 3. AUTHORIZATION TO SIGN AN AGREEMENT OF COORDINATION WITH STATE GOVERNMENT FORCES

Mrs. Mayor reminded members of the council to fight more effectively against noise and any delinquency in winter season nuisance, it was envisaged the creation of a night patrol during this period.

Therefore, and in accordance the provisions of Article L512-16 of the Code of Homeland Security, it is suitable for the organization of the service to coordinate the actions of the municipal police with those of the security forces of the state. This organization should be formalized in the framework of an agreement, established the model laid down in Article L512-14 of the same code.

The inventory drawn from the local safety diagnosis made October 19, 2012 revealed the following needs and priorities : Fight against noise especially at night; Keeping the peace; protection of public buildings; Road Safety

In response to this, the town offers the implementation of the following organization:

o Creating a night patrol several times a week beyond 23 hours

o Monthly meeting between the head of the municipal police and the Brigade Commander of Gendarmerie Bozel, Director General Services common Ferriere, and any qualified person these members may require.

o Quarterly Meeting between the Commander of the Gendarmerie Nationale of Bo261 and the Mayor of the town.

To implement all these corrective actions, it is proposed to authorize Mrs. the Mayor to sign the draft agreement coordination, as well as all applications and approvals related to the implementation of these actions.

Municipal Council on the report of the Mayor, unanimously approved the terms of Convention coordination and establishment of a patrol several nights a week beyond 23 hours. Madam Mayor is authorized to sign the draft agreement and all documents necessary for the implementation this folder.

### 4. CREATION OF A MUNICIPAL SERVICE VEHICLES FOURRIERE

the Mayor reminded the council that the town must sometimes face the need to evacuate or abusive vehicles illegally parked on public property. Besides unsightly nature of these vehicles, they expose the natural environment pollution risks related to the flow of fluids and various substances.

To allow evacuation, in accordance with Article 325-12 and following of the Code of the road, it should proceed with the creation of a public service municipal pound.

Insofar as this activity would remain infrequent during the year, the town has human resources to its implementation without requiring staff additional. removal agent is operated by the holder of municipal police, which has the necessary permits for its implementation.

Technically, the towns of Saint Bon Allues and were asked to consider a loan vehicle adapted to the removal, because a few days per year, mainly outside of the winter season.

The envisaged terrain vehicle storage is located at the entrance to the parade, located in the hamlet of Saint John in the town the Ferriere. accordance with the laws it should make some adjustments to the field. For practical reasons, but also to contain their financial impact, these will be implemented as soon as possible, but will probably spread over several fiscal years. Given the low use of the service during the year, arrangements will be made as part of an optimized management of the fiscal capacity constraint relatively

common.

It is therefore proposed to the city council of approve the establishment of a municipal pound, to approve the principal terms of operation and to approve tariffs, in accordance with the Ministerial Decree of 2 March 2012.

Municipal Council on the report of Mrs. Mayor, unanimously approved the creation of a municipal impound service from the 2012-2013 winter season, approves the general operating procedures as outlined above, fixed the maximum rate applicable to all benefits as set by Ministerial Order dated March 2, 2012, approved the implementation of necessary adjustments to the introduction of this service, subject to the appropriations to be entered in subsequent fiscal years and the principle of a loan vehicle suitable for removal from the communes of Saint-Bon and Allues and authorize the Mayor to sign all documents necessary to implement this decision.

#### PEENING 5. CUTS AND MARKETING WOOD 2013

To As we got the ranking tourist town, the first step in the process July 27, 2009.

The municipality has further proceeded to file his application classification classified tourism resort "in July 2012.

After instruction by services of the Prefecture of Savoy, and before sending the file to the Ministry of Tourism, it appeared that we had this issue with a complete absence of deliberation infringement laws and health regulations.

Accordingly, the Mayor offers City Council deliberate to certify the absence of infringement of laws and health regulations because of the tourist town during the last three years preceding the year of application of the ranking.

### 3. MODIFICATION OF THE DECISION OF 9 MAI 2012: AUTHORIZATION OF FILING OF PRIOR DECLARATION - PARKING ST JOHN

the Mayor recalls that prior notification to the completion of a public car park with 20 spaces in the municipality of La Ferriere, located in St. John was previously granted on 13 June 2012.

Or> considering additional studies and technical constraints for the field, it was necessary to partially modify the management plan to integrate the particular issue of accessibility for people with disabilities as well as to account for unforeseen technical constraints related to soil type.

Moreover, it is recalled that by decision of 7 February 2012, the Board has decided in favor of the realization of this public work and all of these characteristics.

Accordingly, it is proposed to the City Council to authorize the Mayor to file a new application for a declaration prior to integrate these various changes.

Municipal Council, after deliberation, to unanimously authorized the Mayor to file a Declaration Prior to regulate parking project located in the hamlet of Saint Jean and sign all documents relating thereto.

### 4. SIMPLIFIED REVIEW OF PLU No. 1: AMENDMENTS TO THE DECISION OF October 19, 2011 June 13, 2012 AND PRESCRIBING THE Lichens PLU AND DEFINING THE TERMS OF THE CONSULTATION PRIOR

the Mayor said that the City Council approved, by deliberations on 19 October amended June 13, 2012, the objectives and modalities of consultation of the simplified revision 1 of the Local Development Plan.in

Following a minimal change in the scope of the proposed simplified revision2011,it is proposed to amend the Municipal Council the deliberations of October 19, 2011 and June 13, 2012 above and decide again on the objectives and modalities of consultation prior to the simplified revision No. 1 Local Development Plan (PLU).

Firstly, the Mayor reminded the City Council sets the general framework and the reasons for the implementation of the simplified revision PLU.

PLU LA PERRIERE was approved by resolution of the City Council dated 30 May 2006 and amended on 21 June 2007 June 29, 2011.'sDevelopment Project and included in the PLU Sustainability states aim to build confidence and strengthen the existing tourism product considering an expansion project of LA TANIA through the development of new types of tourist accommodation unmarked and attractive and complementary equipment. It is to perpetuate the product station and strengthen long-term local economicIssues:.

Background and

Municipality must ensure a sustainable balance of its territory and has the will to continue and strengthen its support to the tourism.

She wants to meet this goal by providing the evolution of the local economic engine Station LA TANIA. Indeed, the size of the station is now below the thresholds to balance commercial and financial autonomy. There has been a parallel aging station and the emergence of new competitive positioning requirements. It is therefore necessary that

the station can grow qualitatively and quantitatively expand range and come

with the creation of new institutions, autonomy and financial balance demand on them to reach a critical size for the financial returns station is at the height of management expenses and investment supported by the municipality.

The project located on the area of Saz parking at the entrance of the station, includes the construction of a complex of accommodation tourism and related services on 12,000 m<sup>2</sup> of floor space, about 1,000 beds.

sector The parking area is classified Saz TO strict the PLU. It is through this review, open to urbanization.

Moreover, the new scope of the project requires a grip on Nsg area next to the runway. It should therefore be marginally change the current zoning to allow the project aforementioned PLU.

Second, the Mayor presents the meeting the implementation of the simplified revision procedure of

When municipality decides to hire a simplified revision procedure, the council must decide on the modalities of consultation involving, throughout the duration of the project development, residents, community groups and others concerned.

**It is proposed under the importance of the project**

to the public by a display hall and station LA TANIA,

a public meeting during the winter or summer tourist season,

the inclusion of a mention in the local press,

the provision of a registry to collect comments from the public at the Town Hall in the days and regular hours .

For all these reasons, the Mayor City Council proposes to continue the simplified revision # 1 PLU for the purposes of carrying Village Project Moretta and open dialogue with the public in the ways mentioned above.

Municipal Council, report on the Mayor, unanimously said that the provisions of the Law of 7 January 1983 relating to the distribution of responsibilities between municipalities, counties, regions and the state as well as articles R.12345 to R.123-25 of the Town Planning Code, transfer common skills in planning. It is up to the municipality to decide on the revision of a Local Development Plan (PLU), change the resolution of 19 October 2011 and the decision of 13 June 2012 approving the objectives and modalities of consultation revision simplified No. 1 Local Development Plan, decided to continue the process for review of PLU as outlined above and approves the terms of the proposed consultation it "before.

The City Council states that, in accordance with Articles R 123-24 and R 123-25 of the Town Planning Code, this deliberation will be posted at the Town Hall for a month and a conspicuous insertion in a newspaper circulated in the department of Savoie , said that this deliberation will be enforceable from the transmission and sub-prefecture of the fulfillment of all formalities of publication above.

Madam Mayor is authorized to commit all necessary steps to implement these decisions. She noted that the terms of the consultation will be conducted jointly with the procedure for amending the BIA La Tania.

#### **5. MODIFICATION OF THE ZAC TANIA: DEFINITION OF TERMS OF THE PUBLIC CONSULTATION**

recalls that the Mayor proposed extension of the resort of La Tania is provided in the Local Development Plan of the town and especially in the Program of Planning and Sustainable Development

To do this, by resolution dated October 19, 2011, as amended June 13, 2012 and December 6, 2012, the town began the simplified revision No. 1 PLU.

Yet, in order to compliance future PLU revised and ZAC La Tania, in its scope and its contents should be some adjustments to records creation and production.

This procedure is parallel to the simplified revision 1 of the Local Plan Urbanism whose primary intent is to open urbanization sector Saz parking area which is classified as a part of AU and the Nsg area.

It aims to amend the records creation and production of ZAC regarding its scope and its urban and economic data, in particular the Programme of Public facilities and assessment of ZAC.

Mrs. Mayor states that, pursuant to Article L 300-2 of the Code of urbanism, modification of Concerted Development Zone must be preceded by consultations for engaging and informing residents, associations and others involved throughout the development of the project.

Moreover, pursuant of Article L. 300-2 of the Town Planning Code, the terms of the public consultation will be shared with those provided under the simplified revision No. 1 PLU.

**Proposals and comments will be considered and will be the subject to review.**

Finally, the approval of the balance sheet of the consultation and approval of the modification file ZAC de La Tania will be subsequent délibérations.

Municipal Council, after deliberation, to unanimously authorized the Mayor to initiate change in the BIA La Tania, approves the terms of consultation prior to the amendment of the BIA La Tania, as defined under the simplified revision No. 1 PLU opting for a joint consultation, authorizes the Mayor to

### 1. TERMS AND CONDITIONS OF MANAGEMENT OF EXPENSES INCURRED BY TRAVEL AGENTS

the Mayor reminded the City Council Decree No. 2007-23 of 5 January 2007, which extends to officers of local authorities and public institutions to simplify the conditions and terms of settlement costs of temporary movement already made for servants updating the provisions of Decree No. 2001-654 of 19 July 2001.

These new regulations alleviate the production of certain documents to the public accountant (as transportation, toll ticket ...) and responsabilisemt local officers leading them to define their own policy for temporary

visits.'sdeliberative assembly is responsible for setting the many tariffs, resulting deliberation adds to the list of documents to be sent to accounting in accordance with Decree No. 2007-450 of 25 March 2007. It is stated that the decree 2001-654 opens the possibility for deliberative change for special situations, maximum amounts of these payments and this within the limits of costs incurred by the agent.

Orders mission are established for govern all temporary movement of territorial agents of the Commune. It is orders of specific mission. Considered as an agent on a mission in service, with a mission order issued prior to the mission, which moves to the execution of the service beyond its administrative home and out of her family home. also the Mayor said that the Finance Act fell compulsory dues paid by local authorities to CNFPT to ensure training of local officials (0.9% instead of 1%).
