## PREAMBLE TO CITY

COUNCIL/ APPROVAL OF THE MINUTES OF THE MEETING OF 6 December 2012 The report of December 6, 2012 was adopted unanimously by the members present or represented-.

### **I-FINANCE**

#### 1. AWARD OF A CASH ADVANCE ON THE GRANT 2013 PAY

#### THE ASSOCIATION "HOUSE OF TANIA"

the Mayor informed the City Council that) by letter dated December 19, 2012, the "House of The Chipmunks' Association requested the grant by the municipality of an advance on the grant for the year 2013. This application is designed to meet temporary cash flow problems.

To ensure the functioning of the Office of Tourism in all its missions, it is proposed to the City Council the payment, pending a decision on the grant in 2013, a cash advance to meet the immediate costs of the association.

The final agreement on the allocation of a lump sum will be determined during the initial budget vote in 2013.

The advance payments will be as follows:

0 1 "payment in January: 60 000.00 €

0 second installment in March: 35 € 000.00

The City Council on the report of the Mayor, unanimously decided to grant cash advance at the Tourist Office of LA TAN IA to meet immediate expenses, in the amount of  $\notin$  95,000 divided according to the above schedule, said that the final agreement on the allocation of a lump sum will be given during the preparation of the 2013 original budget, specifies that the appropriations corresponding operation will be included in Chapter 65 "Other current operating expenses" in the 2013 budget.

#### 2. SETTING CONDITIONS OF PARTICIPATION FEE RELIEF FORSEASON

#### TOURISTWINTER 2012/2013

the Mayor reminded the council that Article 54 of Law No. 2002-276 of 27 February 2002 on local democracy has changed Article L. 2331-4 of the General Code of Local Authorities by enabling municipalities to require practitioners on sports and leisure or their dependents participation in rescue costs.

Article L. 2331-4 of the General Code of Local Authorities has, in addition, municipalities must determine the conditions under which it is effected participation may cover all or part of the expenses incurred by the community.

Against this background, the Mayor offers City Council:

o to decide that the financial contributions required of stakeholders and their rights to relief they benefited during the winter tourist season successors will cover all expenses incurred by the municipality plus a package management Emergency 24 €measure:.

# 3. MODIFICATION OF THE DECISION No. 063-2012 APPROVING THE GENERAL OPERATING THE CENTRE OF TANIA FOR WINTER SEASONPROCEDURES

#### 2012-2013- ADDING A RATE

Mrs. Mayor reminded the council's decision of October 25, 2012 adopting the general operating procedures of the center of the Chipmunk for the 2012-2013 winter season.

It is apparent that previous rate applied during the 2012-2012 season for residents Tania has not were included in the deliberation and yet it is a significant demand from users who reside part of the year in the municipality.

It is therefore proposed to the City Council to incorporate the fee schedule the following prizes :

o For owe a local direct tax on the common Ferriere under the year 2012, it will be charged to the

opening hours of tourist structure, the sum of € 3 per hour guard

o.In addition, for these users, a fee of € 8 per meal surcharge will be applied when the child have lunch

in the structure.
